- Reinstatements extension of study period –student could complete MCU will explore
- o If student WD & wanted to return, can that be processed as a reinstatement?
- Allowing new apps online would save majority of reinstatements
- Comprehensive review of academic progress Chairs will be discussing with Saba in their meeting at end of September
- Distance calculation doesn't work if students can't find their program/cost code on the app – this defaults to home/main campus. When cost code is corrected, it does not calculate the actual distance

New Business

- **BSWD Transfer Payment Agreement** Lots of discussion over email about this new requirement. Is there any feedback that should be forwarded to MCU?
 - Will this be implemented for other scholarship programs?
 - o Why report? Info is already included in BRS?



- Report states from April 1, 2024 (but TPA email was received in August)
- Budget is perplexing why budget? We are obligated to pay out for students anyways?
- Why can't BSWD/CSG-DSE come via EFT directly to students?
- Scholarship info (ie: Ukraine, Remembrance, First Gen, Indigenous, etc) we should have this information by May 1st so we can budget, advertise, etc --- Refer to MCU
- Automatic communication when downgrading probation/restriction Recommending that students be notified they have returned to good standing, plus a reminder of the academic progress requirements
 - o when placing an instance, it asks if we want to inform the student.
 - But, when we downgrade & bring to good standing we should be asked to automatically notify the student can this be added: 'would you like to notify student'? Add to Systems
- **Signature Pages** In addition to pop-up warning about electronic signatures, we had requested a warning right above the signature panel on the actual forms
 - Pop-up stating ACTUAL signatures is good but we had requested the same wording on the actual forms – Refer to MCU
- Extenuating Parental Circumstances form For 2025-26, can form be updated to list what the Ministry considers arbitrary reasons to refuse support?
 - Sometimes cultural reasons or program choice is being selected for extenuating parental circumstances
 - Can MCU have a listing of arbitrary reasons upfront on the form -- No, the arbitrary reasons can be found in the manual & students would just list one of the acceptable
 - It is up to Fin Aid officer to relay the reasons & to discuss that 'extenuating' means a serious rift
 - Let's ask MCU to ask for a query of the number of Family Breakdown appeals this review has been discussed for many years – Refer to MCU
 - o Great roundtable at conference how does MCU deal with these out-of-province reviews?
- Bankruptcy Reviews Confusion over messaging "if you had previous student loans that
 were paid in full. Recommendation to remove "that were paid in full" and just state "if
 you had prior student loans . . . you must provide proof of no balance owing"
 - Very unclear; request to remove that phrase Refer to MCU

OLSG Complaints

MCU promotes that the program covers the cost of tuition, fees, and books.
 However, due to maximums in the cost code guide, students are left underfunded and frustrated with program



- OLSG Website for program eligibility is too vague. Needs to specifically state that only the Nipissing on campus program is eligible, not the distance program.
- MCU communication to El's regarding issues with program eligibility is inadequate and unacceptable. There is no accountability or transparency from the ministry regarding OLSG administration.
 - Holds were placed on all OLSG applications following COE and FAA was not advised

Refer to MCU

- Level of transparency & communication needs to improve
- O Students are not getting enough total funds to cover the educational fees
- Textbook costs if over 3 characters, you need override (ie: \$1100 needs override). If overriding for OLSG, you also need to override those that also get OSAP
- Needs better communication on their website (re: compulsory fees not covered, 'allowable' compulsory fees, maximum textbook costs?, etc)
