#### 1. Business Arising

- **G2L Messaging (2022-02-24)** OASFAA looking for improved messaging as the standard warnings confuse students and cause panic.
  - Standard warnings given when docs are pending this shouldn't happen
  - Can we get a copy of the warning notices given?
  - Then, procedures can review -- defer to Procedures Committee
- TRM: Increase of Minimum Amount to Student (2022-02-24) OASFAA requesting MCU increase threshold to above \$100 for refund direct to student. Would decrease volumes of refunds processed at high population schools
  - Do we have stats re: how many TRMs
  - Also, can we estimate what the cost is?
  - Don't have to send TRMs back unless there is an overpayment
  - Can it be raised to \$500? Can a survey take place within membership? -- Shaun to followup; create survey
- **Professional Judgement** Add a clause in manual for Financial Aid Officers to be able to use their 'professional judgement'
  - o 'professional judgement' is implied at each institution
  - MCU cannot add general statements like this in policies
  - Remove from list
- Part-Time OSAP: Child Care Costs for Online Courses- Not an allowable cost
  - Why is child care not included for part-time applications for online courses (but it is for inperson courses)?
  - Online isn't necessarily asynchronous; a lot are synchronous now. So, specific time slots require day care refer to MCU justification of policy & can it be reconsidered
- 2. Chair's Report
  - Opportunity to Meet with ESDC re: Canada Learning Bond Will be in downtown Toronto on May 7 – 9 and looking to meet to discuss how to support efforts to raise awareness.

- 40-day document deadline meeting with Krista suggested FAOs would have discretion as what does and doesn't fall into this deadline, outside of processing-type and review docs
  - Discretion to accept docs past deadline?
  - Maybe bring in Compliance (ie: if we accept past, are we going to be noted?)
    - o Jeremy to follow-up for further discussion
- Proof of Indigenous Status Policy committee is supportive of document requirement being tightened up. Recommendation for MCU to return to Indigenous stakeholders for consultation
  - $\circ$   $\;$  Docs should be from an Indigenous organization; not necessarily an affidavit
  - Students get 'free tuition' in some cases so could be considered fraud if doc is accepted (ie: self-identification) – defer to next meeting



- BSWD Is eligibility determined at point of COE or when FAO reviews application? Will be referred to DIWG for review
  - Follow-up TBD
